Listed below are the participation guidelines for this fundraising event:

- Marketplace participation is open to Constituents, Components, and other ADHA affiliated organizations only.
- A limit of **one** Constituent, Component or ADHA affiliated organization will be allowed at each table
- Commercial manufacturers or commercial distributors of products are not allowed in the Marketplace.
- Items sold must not conflict with products sold by commercial exhibitors. For example, toothbrushes and dental floss may not be sold in the Marketplace. Please be sure that articles for sale are not disrespectful to the profession of dental hygiene.
- Marketplace spaces must be manned by ADHA members who have registered for the CLL/Annual Session.
- The **Marketplace fee is \$125.00**. Those who will need an easel must enclose an additional \$10.00. (These fees are non-refundable.)
- Each Marketplace space will be supplied with one (1) six foot table, two (2) chairs, and one (1) identification sign.
- Nothing shall be posted on, nailed or screwed or otherwise attached to columns, walls, floors, tables or other parts of the hotel furniture including drapery.
- Nothing shall be placed in the aisles between Marketplace spaces. All items sold must be confined to the table top, and sold only during Marketplace hours.
